#### Class Overview

This class will explore the determinants of economic growth in the long run, as opposed to fluctuations in economic growth due to business cycles. It will dig deeper into questions you may have studied in intermediate macroeconomics (Econ 3334), which is a prerequisite.

#### Class Materials

- While the course is run through Canvas, the main content of this course is hosted at <a href="https://growthecon.com/StudyGuide">https://growthecon.com/StudyGuide</a>. A link to this site is located on Canvas. The materials here are all hosted outside of Canvas so that I can support some embedded items Canvas doesn't like. Most important for you, the material on quizzes and tests is based \*solely\* on what we discuss in class meetings and on this study guide.
- The format of the class is something like a "flipped" classroom. My expectation is that you'll have looked through the appropriate material for each class meeting and then class meetings will be for me to expand on that material, for you to ask questions, and for us to work through examples of applying what was in the material.
- There is a book that is \*optional\*. You may find it useful to read further on certain topics. But no matter what, the study guide website above overrides the book. The book is <u>Introduction to Economic Growth</u>, by Jones and Vollrath, 4<sup>th</sup> Edition.

• Some assignments require you to work with data in Excel (or Google Sheets). You should have access to a computer with Excel on a regular basis. Excel is available for free through UH by logging into AccessUH and using the "Office 365" button.

### Grading

I use a slightly different grading system than you are used to, and it effectively allows you to "choose your own grade" by the amount of work you are willing to put in.

First, let me explain the different assignments and evaluations that will be used. Each one shows the total points from that assignment. There are a total of 760 points for the whole class.

- **Syllabus Quiz (0 points)**: You must complete a syllabus quiz with 100% to proceed with the class by the due date listed on Canvas (about a week after class starts). Most of the class material will not unlock until you do this. You can take the syllabus quiz as many times as you like until you receive 100%.
- Attendance (450 points): You need to attend regularly. If you attend 22 or more of the 28 classes, you will get the full 450 points. If you attend 21 or less, you will get zero points. See the attendance section below for more details.
- Quizzes (120 points): There are 8 quizzes, 15 questions each. These are all hosted on Canvas and are multiple choice.
  - You can take each quiz as many times as you like.
  - There is a bank of questions, so each version of the quiz you take will be different, although some questions may repeat themselves.
  - Each Quiz has a due date (listed on Canvas). You can take a Quiz after the due date, but you lose 2% of the points for each day it is late. After 10 days you will lose 20% of the points, which could prevent you from completing all the quizzes and tests.
- **Tests (90 points)**: There are 3 tests, each with 30 questions. These are all hosted on Canvas and are a mix of multiple choice and calculations, and they refer to specific material on the Study Guide site.
  - The tests will reuse some questions from the quizzes.
  - These also have a bank of questions, and each version of the test will be different, although some questions may repeat themselves.
  - You can take each test as many times as you like.
  - Each Test has a due date (listed in the course calendar below). You can take a Test after the due date, but you lose 2% of the points each day it is late. After 10 days you will lose 20% of the points, which could prevent you from completing all the quizzes and tests.
- **Project (100 points)**: This is either a paper, a recorded presentation, a program/spreadsheet, or an empirical analysis.
  - Doing the project is optional (see below).
  - Each person works on a unique project.
  - I describe the options for the projects in a separate document posted on Canvas.
  - If you choose to do a project, you must sign up for a specific project on Canvas by the due date listed there.

- o If you turn in a first draft of your project by the due date listed on Canvas, I will provide comments that you can incorporate to get a better grade.
- o Your final project is due by the date listed on Canvas. **No late projects are accepted.**
- There is no separate final exam for this course

Second, let me explain how grading works. Your final letter grade is determined by your total points out of 760, according to a standard grading scale: 93+%: A, 90-93%: A-, 87-90%: B+, 83-87%: B, 80-83%: B-, and so on. In borderline cases (you got a 90%) I will give you the higher letter grade.

However, in this class you can only progress through the material if you meet certain minimum scores on quizzes and tests to "unlock" later material. Think of this as a contract between you and me.

- 1. If you put in the effort and time to meet those minimums...
  - a. You can take the guizzes and tests multiple times to reach the minimum.
  - b. Beware of the deadlines. If you are very late, you won't be able to reach the minimum. There is no way to "make it up on the final".
- 2. ...then you will get the grade you earned by meeting those minimums.
  - a. There is no high stakes take-it-one-time test that can affect your grade.
  - b. If you do the work, you will get the grade specified. No surprises.

Based on the requirements these are examples of how to reach certain grades:

- 1. **Getting an F**. You need to attend 22 or more classes to get the full 450 points for attendance. If you attend 21 or fewer you will get zero points for attendance. Even if you get \*all\* the other points on quizzes, etc., you'd still get 310/760 = 41%, which is an F.
- 2. **Getting a D-**. If you attend 22 or more classes and average 5/15 on the first three Quizzes, you'll get (450+15)/760 = 61%, a D-.
- 3. **Getting a C-**. If you attend 22 or more classes and complete all the Quizzes with 12/15, then you'll get (450 + 12\*8)/760 = 71.8%, a C-.
- 4. **Getting a B-.** If you attend 22 or more classes, complete all the Quizzes with 12/15, and complete all the Tests with 24/30, then you'll get (450+12\*8+24\*3)/760 = 81.3%, a B-.
- 5. **Getting a B+ or more.** If you attend 22 or more classes, complete all the Quizzes, complete all the tests, and submit a final project, then you'll get at least a B+. The exact grade will depend on your points on the first draft and final draft of your project.

In each case you can move those grades up by scoring above the minimums on the quizzes and tests. Remember, you can retake them as many times as you like.
